What is the overall deductible?	\$0. Out-of-Network: Individual \$500 / Family \$1,250.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your deductible?	Yes. Emergency care is covered before you meet your <u>deductible</u> .
